With regards to the exchange of transactions within the CORE system, STET charges its Direct and Indirect Participants for each calendar year a total price based on:

- The volume of transactions processed in the CORE system
- The type of processed transactions.

STET also invoices for additional services:

- Connection to CORE(FR) charged once to the Direct Participant on the date the connection is set up;
- MINOS documentation;
- Statistics and commissions" service for group members;
- Access service to the documentary extranet CORE(FR);
- Target2 settlement account switching service;
- Exceptional Repository Release Service;
- Traceability.

Tariffs 1, 2 or 3 apply to any Direct Participant on the basis of the total number of Transactions sent and received on the CORE(FR) system by that Direct Participant and the REachable Entities it represents during a calendar year N-1. A verification is carried out at the end of year N to confirm the Tariff (1, 2 or 3) on the basis of the overall and effective total of Transactions exchanged during year N on the CORE(FR) system.

The fixed annual fees (Direct Participants and Indirect Participants) are invoiced at the beginning of each year. Variable fees are invoiced quarterly.

Tariffs 1, 2 or 3 apply to any Indirect Participant based on all Transactions sent and received on the CORE(FR) system by this Indirect Participant during a calendar year N-1, regardless of the Direct Participants who represented it during the year, regardless of the total volume of Transactions (there is no end-of-year regularization).

2.3 Discount on on-us transactions

Any On-Us Transaction sent or received by a Direct Participant benefits from an exceptional discount of 50% of the tariff per Transaction on the basis of the pricing schedule specified in point 2.1.

On-us Transactions of a Direct Participant correspond to any Transaction exchanged between two entities, regardless of their status (Participant, member of the Banking Group or client of the Specific Traceability Service), represented by the same Direct Participant.

3.2 Statistics and commissions" service for group members

The "Statistics and Commissions" service is applied to Banking Group members, with the same subscribed flows and the same VAT liability as their parent company Direct Participant, which are explicitly described in the Repository (i.e. "real mode") at the request of the Direct Participant.

This service provides detailed information in the monthly statistical statements and in the "participant" level commission statements.

The "Statistics and Commissions" service is invoiced at the beginning of each year on the basis of the CORE reference database as of 2 January of year N. Any year started is due: after the date of January 2 of year N, any new Group Member meeting the above-mentioned criteria is only billed for year N+1 and a Direct Participant must honour the billing for year N in its entirety for any Group Member declared to have left during year N.
